**Issue:** Currently we only hold language in our By-Laws to outline PAC member participation. We have no language outlining non-member volunteers.

#### Details:

We would like to add the following section in the By-Laws regarding volunteers between Other Officers and Special Committees and Representatives:

Volunteers (Member and Non-Member)

- 1. All Volunteers:
  - a. Must adhere to the rules and spirit of the PAC Bylaws and Constitution
  - b. Must be under direction or supervision of an active PAC Executive Member or Officer
  - c. Must be active (Member Volunteer) in the PAC or have been an eligible or active member of the RMS PAC within the last 2 school years (Non-Member Volunteer)
- 2. Non-Member Volunteers:
  - a. Are not eligible for Elected or Non-Elected Positions within the RMS PAC
  - b. Do not have vote or voice on PAC issues or decisions
  - Non-Members will become Members if one of their children enters the RMS school as an attending child
